VOLUNTEER ACKNOWLEDGMENT AND RELEASE FORM

I acknowledge my obligation to refrain from any conduct that is inconsistent with my volunteer status, including, without limitation, engaging in violence or threats of violence, theft or destruction of City property, or sexual or other forms of harassment.

In consideration for my (or my minor children's) being permitted to volunteer for the City, I hereby expressly assume all risks and hazards incidental to my (or my minor children's) participation in volunteer activities for the City and assume full responsibility for all risks of bodily harm and property damage resulting from or in connection with my (or my minor children's) participation in the volunteer activities.
